<b>Definition:</b>	Whether the person is a student.
<b>Context:</b>	<p>Certain payment types such as Youth Allowance, Austudy, and Special Benefit have study or training eligibility requirements. This in turn can impact the person's eligibility for Commonwealth Rent Assistance (CRA).</p> <p>This information may be important in terms of determining the extent to which assistance is provided to students, the likely duration of housing need and locational requirements.</p>

### Collection and usage attributes

<b>Comments:</b>	<p>Prior to 13 March 2018, the definition of the 'Person' Object class was 'A human being, whether man, woman or child'. From 13 March 2018, the definition was edited by removing the words '...whether man, woman or child' so that a person is defined as 'A human being'. This amendment was undertaken to align the definition of a person with the <i>Australian Government Guidelines on the Recognition of Sex and Gender</i> and the Australian Bureau of Statistics (ABS) <i>Standard for Sex and Gender Variables</i>, which recognise that there are sex and gender types that are not exclusively male or female.</p>
