## Collection and usage attributes

<b>Guide for use:</b>	This metadata item should always be recorded as an 8-digit valid date comprising day, month and year. Year should always be recorded in its full 4-digit format. For days and months with a numeric value of less than 10, zeros should be used to ensure that the date contains the required 8 digits. For example the date July 1 2002 should be recorded as 01072002.
<b>Collection methods:</b>	Where possible, the actual date that the payment is made should be recorded, regardless of when it is administratively recorded. In order to accurately measure rent arrears, this metadata item should be linked to the Household—rent paid (weekly), total Australian currency N[NNNNN].NN
