<b>Guide for use:</b>	<p>A client is identified as commencing a treatment episode if one or more of the following apply:</p> <ul style="list-style-type: none"><li>• they are a new client,</li><li>• they are a client recommencing treatment after they have had no contact with the treatment provider for a period of three months or had any plan in place for further contact,</li><li>• their principal drug of concern for alcohol and other drugs has changed,</li><li>• their main treatment type for alcohol and other drugs has changed,</li><li>• their treatment delivery setting for alcohol and other drugs has changed.</li></ul>
