<b>Rationale:</b>	Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health care services know the smoking status of clients in order to provide appropriate medical care.

<b>Numerator:</b>	<p>Calculation A: Number of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded as "current smoker".</p> <p>Calculation B: Number of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded as a "ex-smoker".</p> <p>Calculation C: Number of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded as a "never smoked".</p>
