This is the name of the entity that appears on all official documents or legal papers.</p> <p>CODE MTR Main trading name</p> <p>The main name that the organisation trades under or the name by which suppliers or customers know the organisation.</p> <p>CODE OTR Other trading name</p> <p>An alternative trading name for an organisation.</p> <p>CODE OTH Other</p> <p>Other name type not listed, e.g. sales and marketing.</p> <p>CODE UNK Unknown</p> <p>There is no information about the name type.</p>
