<b>Guide for use:</b>	The authorisation start date is the date from which the carer household was authorised (including provisional authorisation) to have a child placed in their care.
<b>Collection methods:</b>	When an estimate is required, all known fields should be entered (e.g. if year and month are known use 01MMYYYY; if the exact date is unknown but the reporting period to which it relates can be determined, use 0107YYYY).  If the date is not known and can't be estimated, record 01011900.
