Collection methods:

- Australian Government funding.

Funding received by states or territories through the National Partnership Agreement on Early Childhood Education or the National Partnership Agreement on Universal Access to Early Childhood Education should be **included** under state or territory funding.

<u>Australian Government funding refers only to funding</u> for Child Care Benefit (CCB)-approved services that provide an early childhood education program. These are predominantly Long Day Care services that also provide an early childhood education program.

Funding of services primarily for capital works should be excluded.

This item categorises services by funding type to provide contextual information for the Report on Government Services (RoGS).

This item will allow early childhood education data from the National Early Childhood Education and Care Collection to be disaggregated by the service funding type (e.g. if reporting the indicator 'children enrolled in an early childhood education program', data could be disaggregated by those enrolled in a service that is government funded, or those enrolled in a service that is privately funded
