 left the service (e.g. have ceased education or changed services), or have been absent without explanation for four continuous weeks (excluding school vacations) prior to the reference period. **Collection methods:** The number of Indigenous children enrolled in an early childhood education

program should be collected for each early childhood education program available at the service. These data should then be aggregated to the service provider level

for reporting purposes.

Each child should be counted only once.

Enrolments in an early childhood education program should be reported for the

specified reference period.
