Including community-based ambulatory services and outpatient services.</p> <p>The following services are currently not included in the coverage:</p> <ul style="list-style-type: none"><li>• services based in prisons and other correctional institutions;</li><li>• agencies that provide primarily accommodation or overnight stays such as 'sobering-up shelters' and 'half-way houses';</li><li>• agencies that provide services concerned primarily with health promotion;</li><li>• needle and syringe programs;</li><li>• agencies whose sole function is to provide prescribing and/or dosing of methadone; and</li><li>• acute care and psychiatric hospitals, or alcohol and drug treatment units that report to the Admitted patient care NMDS and do not provide treatment to non-admitted patients.</li></ul> <p>Clients who are on a methadone maintenance program may be included in the collection where they also receive other types of treatment.</p>
