Computation description:	<p>For the numerator and denominator, there may be one or more prescriptions for any one patient during an episode of care. All prescriptions meeting the criteria for the numerator or the denominator should be counted.</p> <p>For the numerator, 'documented' means the prescriber has recorded the indication or reason for prescribing the antimicrobial in the patient's healthcare record. To be counted towards the numerator, the documented indication should be clear and specific enough for decision making and intervention if necessary. For example, use terminology consistent with <i>Therapeutic Guidelines</i> or locally endorsed guidelines such as 'community-acquired pneumonia'. Documenting indications such as 'infection' or even 'chest infection' are unlikely to assist in ensuring antimicrobial treatment is optimised, and should not be counted as meeting the requirement for the numerator.</p> <p>Presented as a percentage.</p>
Computation:	$(\text{Numerator} \div \text{Denominator}) \times 100$
Numerator:	Number of prescriptions for which the indication for prescribing the antimicrobial is documented.
Denominator:	Number of prescriptions for antimicrobials.
