Context: Income units are restricted to relationships of marriage (registered or de facto) and

of parent/dependant who usually reside in the same household. This means that

an income unit can be defined as:

• a married couple or sole parent, and dependent children only

a married couple only with no dependent children present

a person who is not related to any other household member either by

marriage or by the parent/<u>dependant</u> relationship.

This is the standard statistical unit for analyses of economic wellbeing, and can be

an important measure in assessing the needs and circumstances of individuals and

families.
