Identifying and definitional attributes

Metadata item type:	Data Element Concept
METEOR identifier:	269755
Registration status:	Housing assistance , Retired 10/02/2006
Definition:	The value of total income from all assessable sources. The assessable sources are those specified and used by the agency to establish eligibility for receipt of a housing assistance.
Context:	Assessable income is also used to calculate the rental housing rebate, that allows the household to pay a rent lower than the market rent. Each state and territory uses its own definition of 'assessable income'.

Object Class attributes

Identifying and definitional attributes

Object class:	Household
Definition:	A group of two or more related or unrelated people who usually reside in the same dwelling, and who make common provision for food or other essentials for living; or a single person living in a dwelling who makes provision for his or her own food and other essentials for living, without combining with any other person.
Context:	Together with family, household is considered one of the basic groups of social aggregation. Information on household numbers and composition aids in identifying groups within the population such as Indigenous households or the number of people living alone.
Specialisation of:	Person/group of persons

Collection and usage attributes

Guide for use:	<p>For housing data collections, the number of tenancy agreements is a practical proxy for calculating the number of households receiving housing assistance.</p> <p>The persons in the group may pool their incomes and have a common budget to a greater or lesser extent: they may be related or unrelated persons, or a combination of both.</p> <p>Only usual residents of the household are included as members of the household. Visitors to a household are, by definition, excluded from the household.</p>
