## Identifying and definitional attributes

<b>Metadata item type:</b>	Data Element Concept
<b>METEOR identifier:</b>	269808
<b>Registration status:</b>	<a href="#">Community Services (retired)</a> , Superseded 29/04/2006
<b>Definition:</b>	The source by which a person derives most (equal to or greater than 50%) of his/her income. If the person has multiple sources of income and none equal to or greater than 50%, the one, which contributes the largest percentage, should be counted.
<b>Context:</b>	The metadata item is an indicator of the needs and circumstances of individuals and sometimes, used in assessment of income equity.

<b>Object class:</b>	<a href="#">Person</a>
<b>Definition:</b>	A human being.

### Collection and usage attributes

<b>Comments:</b>	Prior to 13 March 2018, the definition of the 'Person' Object class was 'A human being, whether man, woman or child'. From 13 March 2018, the definition was edited by removing the words '...whether man, woman or child' so that a person is defined as 'A human being'. This amendment was undertaken to align the definition of a person with the <i>Australian Government Guidelines on the Recognition of Sex and Gender</i> and the Australian Bureau of Statistics (ABS) <i>Standard for Sex and Gender Variables</i> , which recognise that there are sex and gender types that are not exclusively male or female.
