Context: Income units are restricted to relationships of marriage (registered or de facto) and

an income unit can be defined as:

a married couple or sole parent, and dependent children only

a married couple only with no dependent children present

• a person who is not related to any other household member either by

marriage or by the parent/dependant relationship.

This is the standard statistical unit for analyses of economic wellbeing, and can be an important measure in assessing the needs and circumstances of individuals and

families.
