These are specialised psychiatric hospitals and specialist psychiatric units located within hospitals that are not specialised psychiatric hospitals. Excludes hospital outpatient clinics.</p> <p>2 - Residential care setting The component of specialised mental health services that provides residential care within <a href="#">residential mental health services</a>. Excludes components that provide ambulatory care to patients or clients who are not residents.</p> <p>3 - Ambulatory care setting The component of specialised mental health services that provides ambulatory care (service contacts). They include hospital outpatient clinics and non-hospital community mental health services.</p>
