Collection and usage attributes

Guide for use:	This metadata item should always be recorded as an 8-digit valid date comprising day, month and year. Year should always be recorded in its full 4-digit format. For days and months with a numeric value of less than 10, zeros should be used to ensure that the date contains the required 8 digits. For example, the date July 1 2002 should be recorded as 01072002.
Collection methods:	The date a dwelling is occupied may not be the same as the <i>Housing service episode-assistance commencement date</i> , DDMMYYYY as tenants may move into a dwelling after the <i>Housing service episode-assistance commencement date</i> , DDMMYYYY.
