	May be referred to as <i>person 1</i> , <i>main tenant</i> or <i>tenant 1</i> , <i>principal tenant</i> , <i>household head</i> on application or tenancy forms, or where the dwelling is being purchased, referred to as the <i>mortgagee</i> . Person must be aged 16 or over.
CODE 2	Spouse/partner
	Include defacto, wife, husband and partner of the reference person/tenant.
CODES 3 and 4	Son/daughter
	Include the son(s) or daughter(s) (or step son(s)/daughter(s)) of the reference person and/or spouse.
CODES 5 and 6	Resident
	Include relatives other than son(s)/daughter(s) (step son(s)/daughter(s)), non-related carer, other non-related and non-family member(s).
