## Identifying and definitional attributes

<b>Metadata item type:</b>	Data Element Concept
<b>METEOR identifier:</b>	288171
<b>Registration status:</b>	<a href="#">Health</a> , Superseded 07/12/2011
<b>Definition:</b>	The type of treatment for cancer given as initial treatment for the particular patient.
<b>Context:</b>	This item is collected for surgical treatment, radiation therapy and systemic therapy. It is used for correlating outcome with original intent of the treatment.

## Object Class attributes

### Identifying and definitional attributes

<b>Object class:</b>	<a href="#">Cancer treatment</a>
<b>Definition:</b>	The course of cancer directed treatment or treatments, with defined dates of commencement and cessation, given to the patient by a treatment provider or team of providers. It includes all treatments administered to the patient before disease progression or recurrence and applies to surgical treatment, radiation therapy and systemic agent therapy for cancer.
<b>Context:</b>	This metadata item is required to provide the basis for a standard approach to recording and monitoring patterns of initial treatment for cancer patients.
<b>Specialisation of:</b>	<a href="#">Service/care event</a>
