# **Proxy occupancy standard**

# Identifying and definitional attributes

Metadata item type: Glossary Item

METEOR identifier: 327448

Registration status: Housing assistance, Superseded 19/12/2017

**Definition:** A measure of the appropriateness of housing related to the household size and

household composition.

**Context:** The measure is used to determine the bedroom requirements of a household.

# Collection and usage attributes

Guide for use: Households that require two or more additional bedrooms to meet the standard are

considered to be overcrowded.

For sole parent or couple households with more than four children the dwelling size in terms of bedrooms should be the same value as the total number of children in

the household.

Where more than one of the groups specified in the occupancy standard is present, the needs of the two or more groups should be added together. For example, a sole parent with one child living with the sole parent's parents (three generations) would require 4 bedrooms, that is, 2 bedrooms for the sole parent and child and 2

**Dwelling size required** 

bedrooms for the married couple.

Household component

The appropriate size is not necessarily the current dwelling size.

Only the usual residents of the household are included.

Adults include children aged 16 or more.

Single adult only

Single adult (group)

Couple with no children

Sole parent or couple with 1 child

Sole parent or couple with 2 or 3 children

1 bedroom

2 bedrooms

3 bedrooms

Sole parent or couple with 4 children 4 bedrooms

**Comments:** The proxy occupancy standard is a nationally agreed standard for CSHA reporting

and does not necessarily reflect the jurisdictions/agency's own allocation policy.

The standard is currently being reviewed by the NHDAMG to improve the

applicability across all household types.

There are other standards that are used to measure overcrowding, for example the Canadian National Occupancy Standard. The standard here is based on the standard in Version 2 of the NHADD with the only change being that sole parents or couples with more than four children have a required bedroom size equivalent to

the number of children.
