## Identifying and definitional attributes

<b>Metadata item type:</b>	Data Element Concept
<b>METEOR identifier:</b>	331671
<b>Registration status:</b>	<a href="#">Community Services (retired)</a> , Standard 30/04/2008
<b>Definition:</b>	An alert of the out-of-home care status of a child at the time of the notification.
<b>Context:</b>	This is essential as an alert that the child is recorded in the separate out-of-home care database.

<b>Object class:</b>	<a href="#">Child protection notification</a>
<b>Definition:</b>	A report made to an authorised department by persons or other bodies about an allegation of child abuse or neglect, child maltreatment or harm to a child.
