CODE 2 People from non-English speaking backgrounds  Agencies whose services are targeted at persons whose first language is not English may be classified under Persons from non-English speaking backgrounds.  CODE 3 Other special characteristics  Other is used to classify SAAP agencies that target their services to persons whose primary or secondary characteristics are not included in the primary target group or in any other categories of the secondary target group—for example, an agency specifically targeting homeless persons with a disability.
