The scope does not currently include patients who may be receiving treatment for psychiatric conditions in acute hospitals who are not in psychiatric units.

## Collection and usage attributes

<b>Statistical unit:</b>	Episodes of care for admitted patients
<b>Collection methods:</b>	Data are collected at each hospital from patient administrative and clinical record systems. Hospitals forward data to the relevant state or territory health authority on a regular basis (for example, monthly).

### *National reporting arrangements*

State and territory health authorities provide the data to the Australian Institute of Health and Welfare for national collation, on an annual basis.

### *Periods for which data are collected and nationally collated*

Financial years ending 30 June each year.

<b>Implementation end date:</b>	30/06/2011

<b>Comments:</b>	Number of days of hospital in the home care data will be collected from all states and territories except Western Australia from 1 July 2001. Western Australia will begin to collect data from a later date.
