Submitting data to the Aged Care Assessment Program National Minimum Data Set (ACAP NMDS) is a condition of ACATs receiving Commonwealth funding. ACAT teams submit their data to the state evaluation unit. The state evaluation unit submits their data to the ACAP National Data Repository managed by the Department of Health and Ageing.</p>
