This amendment was undertaken to align the definition<br/>of a person with the Australian Government Guidelines on the Recognition of Sex<br/>and Gender and the Australian Bureau of Statistics (ABS) Standard for Sex and<br/>Gender Variables, which recognise that there are sex and gender types that are<br/>not exclusively male or female.
