An identical reporting structure, including organisation name, should be common between all mental health collections, including the Mental Health Establishments (MHE), Community Mental Health Care (CMHC) and Residential Mental Health Care (RMHC) NMDs, the Mental Health National Outcomes and Casemix Collection and any future mental health collections.</p>
