## Collection and usage attributes

<b>Computation description:</b>	First trimester is defined as the first 13 weeks of pregnancy.  Births include live births and still births where the birth weight was at least 400 grams or the gestational age was 20 weeks or more.  Analysis by state and territory, remoteness and SEIFA Index of Relative Socioeconomic Disadvantage (IRSD) is based on residence of the mother.  Presented as a percentage.									
<b>Computation:</b>	100 x (Numerator ÷ Denominator)									
<b>Numerator:</b>	Number of pregnancies resulting in a birth, where an antenatal visit was reported in the first trimester (up to and including 13 weeks gestation) for at least one live or stillborn baby
