The transfer should have been pre-arranged by the transferring hospital. If the patient passes through Department of Emergency Medicine the source should still be 'Transfer from another hospital'.

Includes other major public hospitals, district hospitals and private hospitals from intrastate, interstate or overseas.

Use for patients transferred from the Transition Care Bed Based Program to the hospital. The patient must be transferred directly from the Transition Care Bed Based Program to this one.
