<b>Computation description:</b>	<p>Proportion of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded at the primary health care service.</p> <p>'Regular client' refers to a client of an OATSIH-funded primary health care service (that is required to report against the Indigenous primary health care key performance indicators) who has an active medical record; that is, a client who has attended the OATSIH-funded primary health care service at least 3 times in 2 years.</p> <p>Results arising from measurements conducted outside of the service, that are known by the service, are included in the calculation of this indicator.</p> <p>Presented as a percentage.</p>
<b>Computation:</b>	$(\text{Numerator} \div \text{Denominator}) \times 100$
<b>Numerator:</b>	Number of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded at the primary health care service.
