Collection methods:	<p>The number of Indigenous children attending a preschool program should be collected for each preschool program available at the service. These data should then be aggregated to the service provider level for reporting purposes.</p> <p>Each child should be counted only once.</p> <p>Attendance in a preschool program should be reported for the specified reference period.</p> <p>Jurisdictions which adopt a two week reference period are required to derive their data to a representative reference week.</p>
