The parent may be the biological, step or adoptive parent.</p> <p>CODE 4 One parent—male</p> <p>This category includes all families with a male single parent. The parent may be the biological, step or adoptive parent.</p> <p>CODE 5 Other relatives/kin</p> <p>Includes relatives other than those referred to above. Also includes Indigenous kinship arrangements.</p> <p>CODE 6 Foster care</p> <p>This category includes situations in which a child is living with foster parent(s) who are reimbursed (or who have been offered but declined reimbursement) by the state or territory for the care of a child and supported by an approved agency.</p> <p>CODE 88 Other</p> <p>This category includes all those not mentioned above. It includes non-family situations, such as hostels and institutional accommodation.</p> <p>CODE 99 Not stated/inadequately described</p> <p>This category is used when the family in which a child lives is not recorded or is unknown.</p>
