A country, even if it comprises other discrete political entities such as states, is treated as a single unit for all data domain purposes. Parts of a political entity are not included in different groups. Thus, Hawaii is included in Northern America (as

part of the identified country United States of America), despite being

geographically close to and having similar social and cultural characteristics as the

units classified to Polynesia.
