The household file information is recorded for all occupants of the dwelling.</p> <p>Indigenous community housing (ICH) collection households, include those living in dwellings:</p> <ul style="list-style-type: none">• managed by Indigenous Community Housing Organisations (ICHO) who received funding both in the current and/or previous financial years; and• targeted to Indigenous people. <p>A principle of the ICHO must be to provide medium-term to long-term housing tenure to tenants. This collection excludes households living in dwellings managed under:</p> <ul style="list-style-type: none">• mainstream community housing (i.e. not managed by an ICHO)• public rental housing• state owned and managed Indigenous housing (SOMIH)• the Crisis Accommodation Program (CAP).
