The household file information is recorded for all occupants of the dwelling.</p> <p>Indigenous community housing (ICH) collection households, include those living in dwellings:</p> <ul style="list-style-type: none"><li>• managed by Indigenous Community Housing Organisations (ICHO) who received funding both in the current and/or previous financial years; and</li><li>• targeted to Indigenous people.</li></ul> <p>A principle of the ICHO must be to provide medium-term to long-term housing tenure to tenants. This collection excludes households living in dwellings managed under:</p> <ul style="list-style-type: none"><li>• mainstream community housing (i.e. not managed by an ICHO)</li><li>• public rental housing</li><li>• state owned and managed Indigenous housing (SOMIH)</li><li>• the Crisis Accommodation Program (CAP).</li></ul>
