<b>Definition:</b>	The total number of group sessions provided to clients by a service provider organisation.
<b>Context:</b>	Required to adequately describe the services provided to clients.  The resources required to provide services to groups of clients are different from those required to provide services to an equivalent number of individuals. Hence, services to groups of clients should be counted separately from services to individuals.
