Rationale:	Smoking is a major risk factor that contributes to ill health. Indigenous Australians are twice as likely as non-Indigenous Australians to smoke. Reducing the rate of smoking among Indigenous Australians will assist in closing the gap in life expectancy.

Data sources for this indicator are the NATSISS (Indigenous); NATSIHS (Indigenous); and NHS 2007-08 (non-Indigenous). The baseline report reported data from the 2008 NATSISS (Indigenous) and 2007-08 NHS (Non-Indigenous). The next available data sources will be the 2011-13 Australian Health Survey (AHS) (sourcing the 2012-13 AATSIHS and 2011-12 NHS).

At this stage, data are available for persons aged 15 years and over only (broader age range is available from the AHS). Data from the NATSIHS are available for remote and very remote areas. The NHS does not cover very remote areas. Baseline year for NIRA target (Close the life expectancy gap within a generation) is 2006; baseline year for this indicator is 2008; target year is 2031.
