Although this data element is recorded in the NAPAAWL DC at the appointment level, it is reported nationally at the service event level.

The NAPAAWL DC gathers all activity information and uses this to ascertain service events. Only the activity that meets the definition of a [non-admitted patient service event](#) will be reported nationally.
