The synonymous name APP_SETTING_CODE is used for local reporting purposes.

The nationally reported data element has the synonymous name SERVICE DELIVERY SETTING.

Although this data element is recorded in the NAPAAWL DC at the appointment level, it is reported nationally at the service event level.

The NAPAAWL DC gathers all activity information and uses this to ascertain service events. Only the activity that meets the definition of a <u>non-admitted patient service event</u> will be reported nationally.
