	For Indigenous people aged 50 years and over, the <i>Australian Immunisation</i> <i>Handbook</i> (DoHA 2008) recommends immunisation against influenza. An Indigenous person aged 50 years and over is immunised against influenza if they have received an influenza vaccine in the previous year.
