

CODE 2 No

Record for a repeat client

A repeat client is a child:

- · who has previously been the subject of an investigation or was discharged (according to national specifications) from any type of national care and protection order or funded out-of-home care placement (including only those respite placements of 7 days or more); and
- whose earliest order and/or placement in the current reporting period is part of a preceding continuous episode of care.
