Guide for use:	<p>If the start date of the current detention period is before the end date of the previous detention period, the detention type of the current period must not be the same as the detention type of the previous detention period.</p> <p>If the detention end reason is 4 (transfer to another youth detention centre within the jurisdiction), the next detention record must start within a day and have the same detention type.</p>
