Collection and usage attributes

Guide for use:	<p>Labour commences at the onset of regular uterine contractions, which act to produce progressive cervical dilatation, and is distinct from spurious labour or pre-labour rupture of membranes.</p> <p>If prostaglandins were given to induce labour and there is no resulting labour until after 24 hours, then code the onset of labour as spontaneous.</p> <p>CODE 3 No labour Can only be associated with a caesarean section.</p>
