## Collection and usage attributes

<b>Computation description:</b>	<p>A generation is defined as 25 years.</p> <p>Life expectancy for total population is calculated for a rolling 3-year period and reported annually.</p> <p>Life expectancy for Indigenous and non-Indigenous populations is calculated for a rolling 3-year period and reported every 5 years.</p> <p>Presented as number of years.</p>
<b>Computation:</b>	Calculated by direct estimation of life expectancy at birth for all Australians, Indigenous and non-Indigenous Australians using the average number of deaths in the 3-year period and the estimated resident population at a mid-point of that period.
<b>Numerator:</b>	The gap estimate does not have a numerator or denominator. The average number of years a person could expect to live from the day they are born if they experienced mortality rates at each age that are currently experienced by the relevant population.
