| <b>Definition:</b>     | <p>The systemic therapy agent or protocol used for treatment.</p> <p>Systemic therapy agents are drugs that travel through the bloodstream and reach and effect cells all over the body. They are administered orally or intravenously.</p> <p>Systemic therapy agents may be administered as single-agent treatments or as a combination of drugs administered according to a prespecified regimen or protocol. A protocol is a precise and detailed plan for therapy that includes the type, quantity, method and length of time of taking the drugs required for any treatment cycle.</p> <p>Systemic therapy agents are encompassed in the treatment modalities <a href="#">chemotherapy</a>, <a href="#">immunotherapy</a> and <a href="#">hormone therapy</a> administered for the treatment of cancer.</p> |
