

This amendment was undertaken to align the definition of a person with the Australian Government Guidelines on the Recognition of Sex and Gender and the Australian Bureau of Statistics (ABS) Standard for Sex and Gender Variables, which recognise that there are sex and gender types that are

not exclusively male or female.
