- · Overactivity attention and concentration
- · Non-accidental self injury
- Alcohol, substance/solvent misuse
- · Scholastic or language skills
- · Physical illness or disability problems
- · Hallucinations and delusions
- Non-organic somatic symptoms
- Emotional and related symptoms
- · Peer relationships
- Self care and independence
- Family life and relationships
- Poor school attendance
- Lack of knowledge nature of difficulties
- Lack of information services/management

The sum of the individual scores of each of the scales from 1 to 13 represents the total HoNOSCA score. The total HoNOSCA score represents the overall severity of an individual's psychiatric symptoms.
