CODE 5 Other solvents/inhalants  
Includes chroming, paint, glue, aerosol cans

CODE 9 Barbiturates  
Includes downers, Phenobarbital, Amytal.

CODE 10 Cocaine  
Includes coke and crack.

CODE 11 Benzodiazepines  
Includes sleeping pills, Valium, Serepax, Mogadon, Rohypnol, Temazepam.

CODE 12 Amphetamines  
Includes ice and speed.

CODE 14 LSD  
Includes acid, trips.
