<b>Definition:</b>	The number of individual session <a href="#">non-admitted patient service events</a> provided by an establishment.
<b>Context:</b>	Required to adequately describe the services provided to non-admitted patients.  The resources required to provide services to groups of patients are different from those required to provide services to an equivalent number of individuals. Hence services to groups of non-admitted patients or outreach clients should be counted separately from services to individuals.

<b>Definition:</b>	Institutions, organisations or the community from which health services are provided. The term establishment covers conventional health establishments and also organisations which may provide services in the community.
