<b>Metadata item type:</b>	Data Element Concept
<b>METEOR identifier:</b>	595868
<b>Registration status:</b>	<a href="#">Housing assistance</a> , Standard 30/08/2017
<b>Definition:</b>	The value of income per week from all sources as specified and used by the agency to establish eligibility of a person for receipt of housing assistance.
<b>Context:</b>	Assessable income is used to determine eligibility for housing assistance.

<b>Definition:</b>	A human being.

### Collection and usage attributes

<b>Comments:</b>	Prior to 13 March 2018, the definition of the 'Person' Object class was 'A human being, whether man, woman or child'. From 13 March 2018, the definition was edited by removing the words '...whether man, woman or child' so that a person is defined as 'A human being'. This amendment was undertaken to align the definition of a person with the <i>Australian Government Guidelines on the Recognition of Sex and Gender</i> and the Australian Bureau of Statistics (ABS) <i>Standard for Sex and Gender Variables</i> , which recognise that there are sex and gender types that are not exclusively male or female.
