<b>Numerator:</b>	Number of patients with a final diagnosis of ACS whose discharge summary has been provided to their GP or relevant health service provider within 48 hours of separation from hospital.
<b>Denominator:</b>	Number of patients with a final diagnosis of ACS separated from hospital.
