<b>Scope:</b>	The Prison dischargée smoking status cluster defines a prison dischargée's history of tobacco use, current smoking status and the quit smoking programs available and used in prisons.

## Collection and usage attributes

<b>Guide for use:</b>	The Prison dischargée smoking status cluster comprises 7 data elements that, in combination, determine a prison dischargée's history of tobacco use, current smoking status and assistance to quit smoking.
<b>Collection methods:</b>	Information on a prison dischargée's history of tobacco use, smoking status and assistance to quit smoking are collected from prisoners who are to be discharged from the prison system in the following 4 weeks from the date of data collection, on the National Prisoner Health Data Collection Prison Discharge form.
